## **Notice of Changes Affecting Your Retirement Plan's Investment Choices**

Prudential recently announced name and share class changes for certain mutual funds it offers, effective June 11, 2018 (the "effective date"), which will affect one or more of the investment choices available in your retirement plan.

Prudential reported that its mutual fund names are changing by replacing "Prudential" with "PGIM" in each fund's name in order to more closely align the fund names with their firm, which was renamed to PGIM Investments in April 2017. Furthermore, Prudential reported that Class Q shares will be renamed Class R6.

On the effective date, investment choice(s) will change as follows:
