

SUMMARY ANNUAL REPORT  
**FOR SEATTLE PACIFIC UNIVERSITY EMPLOYEE SAVINGS PLAN - 403(B)**

This is a summary of the annual report for the Seattle Pacific University Employee Savings Plan - 403(B), EIN 91-0565553, Plan 001, for period July 1, 2017 through June 30, 2018. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Basic Financial Statement**

Benefits under the plan are provided through insurance and through a trust fund. Plan expenses were \$7,223,832. These expenses included \$69,606 in administrative expenses and \$7,154,226 in benefits paid to participants and beneficiaries. A total of 1522 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$68,584,949 as of June 30, 2018, compared to \$67,226,292 as of July 1, 2017. During the plan year, the plan experienced an increase in its net assets of \$1,358,657. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$8,582,489, including employee contributions of \$2,621,595, other contributions of \$137,302 and earnings from investments of \$5,747,245.
